- 3. <u>Benefits:</u> A Benefits Committee meeting is scheduled for March 7, 2013, 10:00 a.m.

4. <u>Legislative</u>: Trustee Ury reported that the Committee is presently monitoring the status and progress of HB13 and SB200. He provided a brief summary of HB13, and reported that the bill as drafted does not apply to the Health Care Fund, but would apply to the Pension Fund. He indicated that the Pension Fund Board was supportive of HB13 and was actively engaged in efforts to secure passage of the bill. As to SB200, Trustee Ury provided a brief summary of the legislation, which is the "Sunset" bill extending the existence of the Pension Review Board (PRB) and making other changes relative to the PRB.

# 5. Administrative Report:

a. <u>Expenses:</u> Mr. Bounds presented the expenditures for the Fund. Upon motion by Trustee Ury and second by Trustee Clancy, a list of expenses and claims and the Financial Report were unanimously approved by the Board.

### 6. <u>Consultant Report:</u>

- a. <u>Legal</u>: No report.
- b. <u>Actuarial</u>: Mark Fenlaw of Rudd & Wisdom presented the actuarial report for the Health Fund as of October 1, 2012. Such report indicates that the current contribution rate of 14.10% is less than the rate necessary to amortize the unfunded liability (15.2%) over thirty (30) years. Upon motion by Trustee Clancy and second by Trustee Trevino, the 2012 Actuarial Report was unanimously approved.

- 9. <u>Members to be Heard</u>: Keely Moffitt, a retired SAPD officer, advised the Board of difficulties she was experiencing with the Fund's new policy regarding generic medication. Mrs. Moffitt's husband, an active SAPD officer, advised the Board that it would be advantageous for him to be able to provide coverage to his wife under his health plan with the City of San Antonio, but that under current plan requirements he was unable to do so.
